## Section 6 - Accidental Release Measures

---

### Emergency Procedures

Large spills:

Wear appropriate personal protective equipment and clothing to prevent exposure. Increase ventilation. If possible contain the spill. Collect the material and place into a suitable, non-leaking, labelled container. Flush remaining residue in area with water and dispose of properly. Dispose of waste according to the applicable local and national regulations. If contamination of sewers or waterways occurs inform the local water and waste management authorities in accordance with local regulations.

Small spills:

Clean up immediately. Avoid contact with eyes, skin and clothing. Avoid breathing vapour. WPick up and dispose of with normal household garbage.

## Section 7 - Handling and Storage

---

### Precautions for Safe Handling

Avoid inhalation of vapours and mists, and skin or eye contact. Do not swallow. Use only in a well ventilated area. Keep containers sealed when not in use. Prevent the build up of mists or vapours in the work atmosphere. Maintain high standards of personal hygiene i.e. Washing hands prior to eating, drinking, smoking or using toilet facilities.

### Conditions for safe storage, including any incompatibilities

Store in a cool, dry, well-ventilated area, out of direct sunlight. Store away from oxidising agents. Store in suitable, labelled containers. Keep containers tightly closed. Store away from incompatible materials. Ensure that storage conditions comply with applicable local and national regulations.

---

### Occupational exposure limit values
